2023 Membership Plans, Terms, and Application

In addition to our various daily fee rates, Glade Valley Golf Club offers discounts via various membership opportunities for those persons that plan to use our facilities on a more routine basis over the course of the year. These plans and their pricing (inclusive of taxes) is as follows:

PLAN 1: Individual Membership, WITH CART: \$1900

PLAN 2: Spouses (total of 2) Membership, WITH CART: \$2700

Note that Plans 1 and 2 above include 1 SEAT in a cart per person.

PLAN 3: Individual Membership, WALKING ONLY: \$1400

PLAN 4: Spouses (total of 2) Membership, WALKING ONLY: \$2000

Note that Plans 3 and 4 require a payment of \$25 anytime a seat in a cart is requested. Riding in a cart that has been rented by others does not alleviate this cart fee requirement.

Each of Plans 1 through 4 are for ANYTIME use (weekday, weekend, or holiday) without a restriction on time of day. In addition, members are defined as individuals that are 18 or older and have signed a membership contract and is paid in full.

Plan 1 through 4 Members may bring guests at a rate calculated by the current time-of-day senior rate less the Valley Card applicable discount. However, this guest rate is limited to 3 guests per day.

PLAN 5: JUNIOR MEMBERSHIP, WALKING ONLY: \$400

Note that junior memberships are for individuals that are 17 and under at the time of membership purchase and are only applicable for tee times Monday – Friday after 10 AM and after 1 pm on weekends and holiday. These are walking memberships only as you must be 18 or older to operate a cart. If a Junior wishes to ride in a cart operated by an adult, there is a \$25 cart fee required to be paid.

PLAN 6: DRIVING RANGE PLAN: \$300 (per person)

Driving range plan allows unlimited range use per person (regardless of any other memberships purchased). Note that range is closed early Monday and Friday mornings for picking/mowing). All range balls need to be obtained from the Pro Shop. Under no circumstances are individuals to enter the range area to pick their own balls.

Other Terms and Conditions of Membership

1. For 2023, memberships can be purchased for a full year (beginning January 1st) or a half year (beginning July 1st). All memberships expire on December 31, 2023. No other prorated plans will be available.
2. Members may reserve tee times up to 14 days in advance.
3. Members receive a 10% pro shop merchandise discount.

- Members can rent range balls at the Valley Card rate.
- Membership plans 1 through 5 include the fees paid to GHIN to establish a USGA golf handicap.
- All members and guests must check in at the Pro Shop before playing and prior to taking any cart from the staging area(s). Members will be issued a Membership Card which MUST be presented when checking in. NO EXCEPTIONS TO THIS REQUIREMENT.
- Membership allows the playing of no more than 18 holes per day, and is subject to availability. A replay fee of \$25 is required should members wish to play more than 18 holes in a given day. Payment is to be made PRIOR to beginning the additional round.
- Membership plans do not apply for members playing in separately held tournaments or league play. Any green or other fees associated with such tournaments or league play are not part of a Glade Valley Membership Plan.
- Annual memberships are non-transferable and non-refundable except in the case of permanent disability.
